ORDINANCE NO. 732

**AN ORDINANCE ESTABLISHING A SPECIAL SERVICE AREA
IN THE VILLAGE OF WARRENSBURG, MACON COUNTY, ILLINOIS,
AND THE LEVY OF TAXES FOR THE PURPOSE OF
PAYING THE COST OF PROVIDING SPECIAL SERVICES
IN AND FOR SUCH AREA TO BE KNOWN AS
SPECIAL SERVICE AREA NUMBER ONE
OF THE VILLAGE OF WARRENSBURG, ILLINOIS.**

WHEREAS, the Village of Warrensburg is a non-home rule unit of local government within Article VII, Section 6A of the Illinois Constitution and, pursuant to the powers granted to it under 65 ILCS 5/1-1 *et seq.*; and

WHEREAS, special service areas are authorized pursuant to Section 6(1) of Article VII of the Constitution of the State of Illinois and pursuant to the provisions of the "Special Service Area Tax Law," 35 ILCS 100/27-5, *et seq.*; and

WHEREAS, the Area is compact and is totally within the corporate limits of the Village of Warrensburg, Macon County, Illinois ("the Village"); and

WHEREAS, the Village of Warrensburg has insufficient resources to maintain its own full-time dispatch center to provide dispatch services for the residents and its Police Department; and

WHEREAS, the Village has entered into an Intergovernmental Agreement with the Central Illinois Regional Dispatch Center for the provision of dispatch services for the Village at an approximate cost of \$20,000.00 per year to provide services the Village cannot provide; and

WHEREAS, the Village has previously determined that the Intergovernmental Agreement with the Dispatch Center and the establishment of Special Service Area Number One was and is in the best interests of the Village and protects the public health, welfare, safety and morals; and

WHEREAS, the Village is taking action to establish said Special Service Area Number One; and

WHEREAS, the revenue from such tax shall be used solely and only for services for which the Village is authorized to levy taxes or to appropriate funds of the Village, for the cost of dispatching, and for the Central Illinois Regional Dispatch Center fees, in which the Village has sufficient interest for the provision of those services; and

WHEREAS, the Area will benefit specially from the municipal services to be provided (the "Services"), and the Services are unique and in addition to municipal services provided to and by the Village and it is, therefore, in the best interests of the Village that the establishment of the Area be considered; and

WHEREAS, the Village has held a public hearing to consider the establishment of the Special Service Area and the tax levy, in compliance with Illinois Compiled Statutes; and

WHEREAS, interested persons affected by the Special Service Area were heard and the Board of Trustees was present to determine all protests and objections at said hearing; and

WHEREAS, no petition as required by Illinois Compiled Statute was filed objecting to the creation of said Special Service Area, the levy or imposition of a tax for the provision of special services to said Special Service Area Number One.

NOW, THEREFORE, BE IT ORDAINED by the President and the Board of Trustees of the Village of Warrensburg, Macon County, Illinois:

Section 1. That the above Recitals of this Ordinance set forth above are hereby incorporated into this text as if set out herein in full.

Section 2. That a Special Service Area in the Village of Warrensburg, Macon County, Illinois be and is hereby established in the territory described as all properties located within the corporate limits of the Village of Warrensburg, Illinois, including the common addresses or tax billing addresses and Permanent Index Numbers for the properties as shown on Exhibit A, attached to this ordinance.

Section 3. That an accurate map of said territory is attached to this ordinance as Exhibit B and is on file in the office of the Village Administrative Clerk of the Village of Warrensburg and is available for public inspection.

Section 4. That the Special Service Area shall be known as Special Service Area Number One of the Village of Warrensburg, Illinois.

Section 5. That the levy of taxes be and the same is hereby authorized and improved to provide for the cost of dispatching and to pay for dispatch fees and related expenses charged by the Central Illinois Regional Dispatch Center.

Section 6. That a levy, as determined by the President and Board of Trustees, of

an annual tax for providing such special services in Special Service Area Number One, in the sum of \$20,000.00 for the fiscal year beginning May 1, 2018, with the tax roll to be used to apply and spread the full-sum levied (\$20,000.00) against all properties identified within the tax roll as specified herein, it being recognized the taxes levied under this Special Service Area Number One are assessed on an *ad valorem* basis.

Section 7. That the levy for Special Service Area Number One of the Village of Warrensburg, Illinois, shall be in addition to all other taxes permitted by law.

Section 8. That the Village Administrative Clerk of the Village of Warrensburg, Illinois shall certify to the adoption of this ordinance, shall cause it to be published in pamphlet form, a certified copy delivered to the Macon County Clerk, and this ordinance shall take effect upon its approval and publication in pamphlet form as so certified.





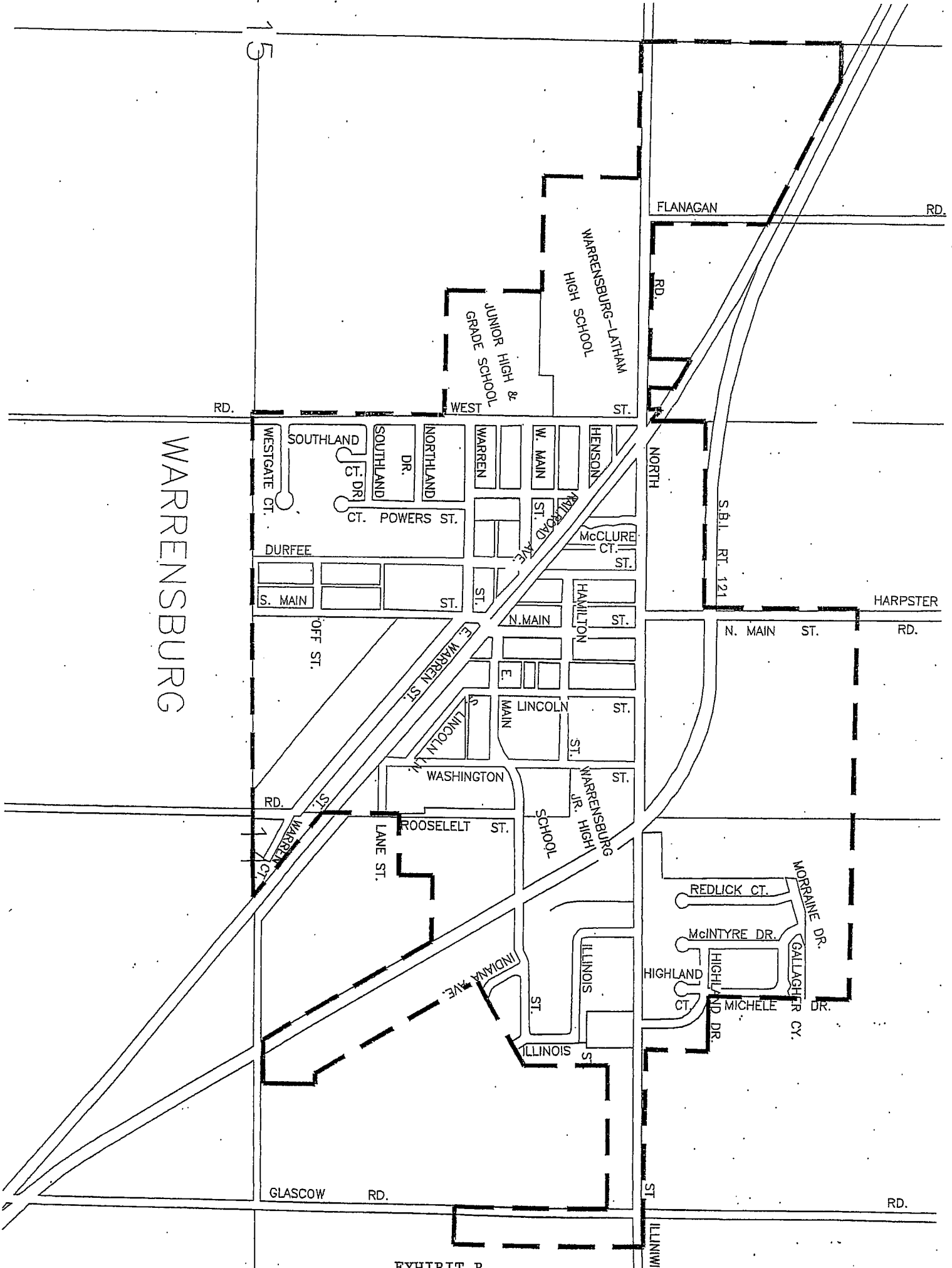
