**ORDINANCE NO. 739**

**AN ORDINANCE AMENDING TITLE 8, CHAPTER 8,  
ENTITLED "PROHIBITION OF TOBACCO USE  
AND ALTERNATIVE NICOTINE PRODUCT USE BY MINORS"  
TO CHANGE THE AGE TO TWENTY-ONE (21)**

**Section 1.** That Title 8, Chapter 8, entitled "Prohibition of Tobacco Use and Alternative Nicotine Products Use by Minors", be and the same is hereby amended by changing the title to "Prohibition of Tobacco Use and Alternative Nicotine Product Use by Individuals Under Age Twenty-One (21)", to read as follows:

**8-8-1 Definitions**

**ALTERNATIVE NICOTINE PRODUCT:** "Alternative nicotine product" means a product or device not consisting of or containing tobacco that provides for the ingestion into the body of nicotine, whether by chewing, smoking, absorbing, dissolving, inhaling, snorting, sniffing, or by any other means. "Alternative nicotine product" excludes cigarettes, smokeless tobacco, or other tobacco products as these terms are defined in this Section and any product approved by the United States Food and Drug Administration as a non-tobacco product for sale as a tobacco cessation product, as a tobacco dependence product, or for other medical purposes, and is being marketed and sold solely for that approved purpose.

**SMOKELESS TOBACCO:** "Smokeless tobacco: means any tobacco products that are suitable for dipping or chewing.

**TOBACCO PRODUCT:** "Tobacco product" means any cigar, cigarette, smokeless tobacco, or tobacco in any of its forms.

**8-8-2 PURCHASE PROHIBITED:** No individual under twenty-one (21) years of age shall purchase any tobacco product or alternative nicotine product.

**8-8-3 POSSESSION PROHIBITED:** No individual under twenty-one (21) years of age shall possess any cigar, cigarette, smokeless tobacco, tobacco in any of its forms, or alternative nicotine product.

**8-8-4: PENALTIES:**

(A) Issuance of Citation: An officer or employee of the Village or any person or persons designated by the President and Board of Trustees of the Village may issue an ordinance violation citation to any person or persons accused of violating any one or more of the Sections of this Code. Said citation shall show the name and address of the accused offender and the date, time, and location of the offense on a form as approved from time to time by the President and Board of Trustees. The citation shall further designate the Code section provided and shall include the issue or signature and date of issuance. Nothing in this Section shall be construed to require the issuance of any citation for any alleged offense.

(B) Settlement: Any alleged offender who receives such a citation for a first offense may settle and compromise the claim against him or her for such alleged offense by paying the Village the sum of one hundred twenty dollars (\$120.00) within fourteen (14) days of the date such citation was dated and received by the alleged offender. The Village Hall is designated as the place for such payment.

(C) Repeat Offense: In the event any alleged offender receives a citation accusing the alleged offender of any violation listed in this Section and having received a prior ordinance violation citation for violation of either Section 8-8-2 or Section 8-8-3 within the period of twelve (12) months, the alleged offender may settle and compromise the second citation by paying the Village the sum of one hundred seventy dollars (\$170.00) within fourteen (14) days of the date such citation was dated and received by the alleged offender.

(D) Failure To Pay: In the event the alleged offender who receives any citation fails to pay the sum as required above within fourteen (14) days, the Village may elect to institute a prosecution for the alleged offense involved.

**Section 2. SAVINGS CLAUSE:** If any part of this Section is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions thereof.

**Section 3. EFFECTIVE DATE:**

This Ordinance shall be in full force and effect on November 4, 2019. The Village Administrative Clerk of Warrensburg shall certify to the adoption of this Ordinance and shall cause it to be published in pamphlet form and this Ordinance shall take effect upon its approval and publication in pamphlet form as so certified.




**CERTIFICATE**
